DEATH, TEMPORARY TOTAL DISABILITY (TTD), & PERMANENT TOTAL DISABILITY (PTD) BENEFITS

Compensation rate multiplied by the number of weeks (or any portion thereof) claimant is off work after three-day waiting period.

TTD, Death and PTD rate = 2/3 of average weekly wage.
PPD rate = 60 percent of average weekly wage, subject to maximums and minimums.
